# LITTLE MAGICAL FAIRY CONTEST

## RULES & REGULATIONS

### General:

1. The Little Magical Fairy Contest is open to girls aged between 4 and 8 years old as of 28 November 2009.
2. You can drop your registration form at The Centrepoint, Causeway Point, Compass Point, Northpoint, YewTee Point, Anchorpoint or Valley Point. All entries must come with a \$10 same-day-same-mall receipt and a recent 4R coloured photograph (non-returnable) of the child.
3. All participants must be citizens or permanent residents of Singapore.
4. The organisers reserve the right to use any of the photos and / or images of any of the contestants for any advertising or publicity material they deem fit.
5. The organisers will not be held responsible for any accidents or injuries to participants or damages to participants' property during the contest.
6. All dates for the Audition, Qualifying Round, Final and rehearsals are fixed and cannot be changed.
7. The judges' decisions are final at every stage of the contest and any dispute in the results will not be entertained.

### Audition (closed door):

8. Contestants will be shortlisted for the Audition based on their entries.
9. Only 50 selected entries will be invited to attend the Audition.
10. Auditions will be conducted on 28 November 2009 at The Centrepoint from 1 pm to 6pm.
11. Those who do not attend the Audition will be automatically disqualified.

### Qualifying Round:

12. 30 contestants will be picked from the Audition to enter the Qualifying Round. The Qualifying Round will be held at the Atrium @ Causeway Point on 7 December 2009 from 2pm to 4pm.
13. The Qualifying Round will require the contestants to participate in two segments - the Magical Fairy Costume Segment and the Talent Segment. The Magical Fairy Costume Segment comprises of a catwalk routine, while the Talent Segment requires the contestant to present a performance item.
14. Those who do not attend the Qualifying Round will be automatically disqualified.
15. All shortlisted contestants must attend a rehearsal on 7 December 2009 from 9am to 11am.

### Final:

16. 15 contestants will be picked from the Qualifying Round to enter the Final. The Final will be held at the Atrium @ Northpoint on 14 December 2009 from 2pm to 4pm.
17. The Final will comprise of three segments as follows:
  - a) Everyday Wear Segment
  - b) Talent Segment
  - c) Magical Fairy Costume Segment
18. All finalists must attend a rehearsal on 14 December 2009 from 9am to 11am.

### Judging:

19. Judging will be based on the following criteria:
  - a) Talent - Competency of the contestant, entertainment value of the performance, and contestant's ability to capture the hearts of the audience.
  - b) Charisma - The conduct, attitude and confidence level of the contestant.
  - c) Costume - How well the contestant's costume fits the theme of the contest.
  - d) Overall Presentation - A good combination of the above that sets the contestant apart from other contestants.
